Context

This is an elective subject offered to students who are close to complete their studies in law, industrial relations or the double degree in law and business. It is taught through the second semester and it is implemented in the "Campus Extens 50" modality, which implies a 50 per cert reduction of the presence-based classes compensated by students' autonomous work guided by the lecturer via online. The subject will provide the students with a deeper understanding of the social dimension of the European Union and the employment legislation founded within it.
